Office hours are Monday through Friday, 8 a.m. to 4:30 p.m. Shortly after returning this form, physical verification of the installed furnace may be required. If so, a Utilities Board representative will contact you.

**Natural Gas 90+% AFUE Furnace Rebate  
Terms and Conditions**

- 1) The furnace you are requesting a rebate for must be a new natural gas furnace and not originally a liquefied propane furnace that has been converted or modified to utilize natural gas.
- 2) The furnace must be installed by a State of Alabama Certified Natural Gas Fitter in accordance with the International Fuel Gas Code.
- 3) The rebate form must be completed by you and your installing contractor.
- 4) You must include with the rebate form a receipt for the purchase of the furnace and an installation receipt from the contractor that installed the furnace.
- 5) The Utilities Board of the City of Oneonta may require a physical verification of the furnace installation. If so, a Utilities Board representative will contact you to set up a meeting at the location of the installed furnace.
